LAW NO 011 OF 2023

SECTION 1

A LAW TO APPROPRIATE THE SUM OF TWO HUNDRED AND TWO BILLION, ONE HUNDRED AND TWENTY-SEVEN MILLION, NINE HUNDRED AND EIGHTEEN THOUSAND, NINE HUNDRED AND SEVEN NAIRA (₦202,127,918,907.00) ONLY TO THE SERVICE OF EBONYI STATE GOVERNMENT OF NIGERIA FOR THE YEAR ENDING DECEMBER 31ST, TWO THOUSAND AND TWENTY-FOUR AND PROVIDE FOR OTHER MATTERS CONNECTED THERETO.

Long Title

SECTION 2

BE IT ENACTED by the House of Assembly of Ebonyi State of Nigeria as follows:

Enactment

SECTION 3

This Law shall be cited as **Ebonyi State Appropriation Law, 2024.**

Short Title

SECTION 4

This Law shall be deemed to have effect as from **Monday, the 1st day of January, 2024.**

Commencement

SECTION 5

The Accountant-General may, when authorized to do so by Warrants signed by the Governor of Ebonyi State of Nigeria, payout of the Consolidated Revenue Fund of Ebonyi State of Nigeria, the sums specified by warrants not exceeding ***Two Hundred and Two Billion, One Hundred and Twenty-Seven Million, Nine Hundred and Eighteen Thousand, Nine Hundred and Seven Naira (₦202,127,918,907.00) Only*** in the fiscal year ending 31st December, 2024.

SECTION 6

The sum of ***Sixty-Nine Billion, Three Hundred and Twenty-Three Million, One Hundred and Seventy-Eight Thousand, Nine Hundred and Seven Naira (₦ 69,323,178,907.00) Only*** shall be appropriated to the heads of Recurrent Expenditure as indicated in the First Schedule to this Law.

SECTION 7

The Accountant-General may, when authorized to do so by Warrants signed by the Governor of Ebonyi State Government of Nigeria payout of the Capital Development Fund of Ebonyi State of Nigeria for the year ending 31st December 2024 total sum of *One Hundred and Thirty Two Billion, Eight Hundred and Four Million, Seven Hundred and Forty Thousand Naira (₦132,804,740,000.00) Only.*

SECTION 8

The sum of *One Hundred and Thirty-Two Billion, Eight Hundred and Four Million, Seven Hundred and Forty Thousand Naira (₦132,804,740,000.00) Only* shall be appropriated to Capital Expenditure as indicated in the Second Schedule to this Law.

SECTION 9

No part of the sums mentioned in Sections 6 and 7 shall be issued out of Consolidated Revenue Fund or Capital Development Fund after 31st December 2024.

The Purpose of this Law is to authorize withdrawals from the Consolidated Revenue Fund of the State for the year ending December 31st, 2024 and other Connected Matters.


