 - ii. Disbursement accruing from the SABER Program is a credit from the World Bank on-lending to the States for a tenure of 30 years at interest rate of 1.25% per annum on the withdrawn Credit Balance.

- 4. The functions of these committees are captured in the Executive Order on FRILIA already signed by Your Excellency. It is also a mandatory requirement for Ebonyi State to earn disbursement under DLI 1 of the SABER Programme.
