



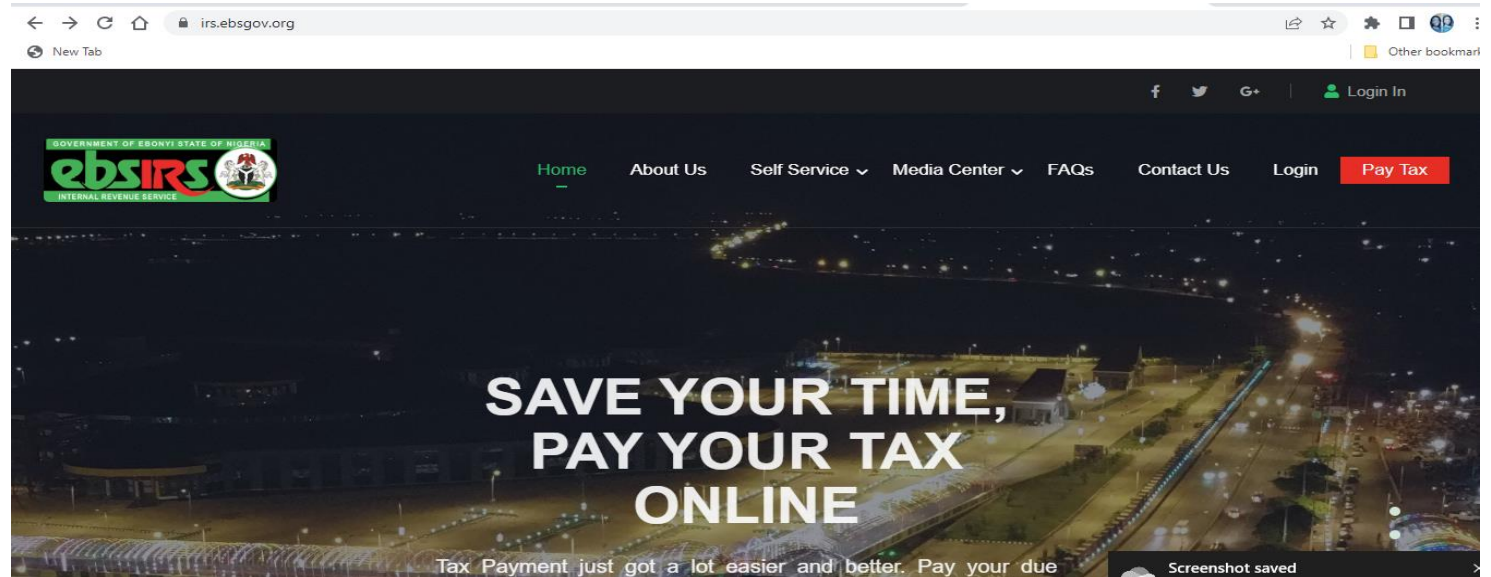

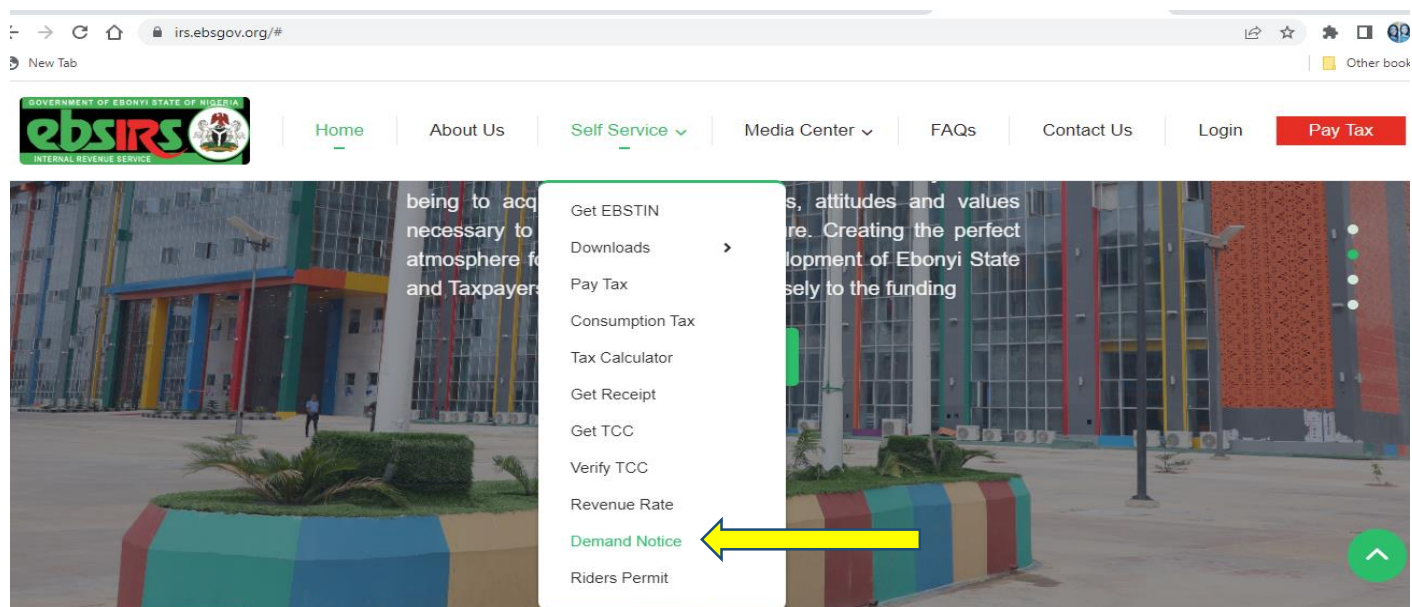

### Steps:

1. Visit [www.irs.ebsgov.org](http://www.irs.ebsgov.org)
2. Place your cursor on “self-service” and follow the drop down menu to obtain “Demand Notice”
3. Click on Demand Notice



4. Fill in the form, select fire service and submit.

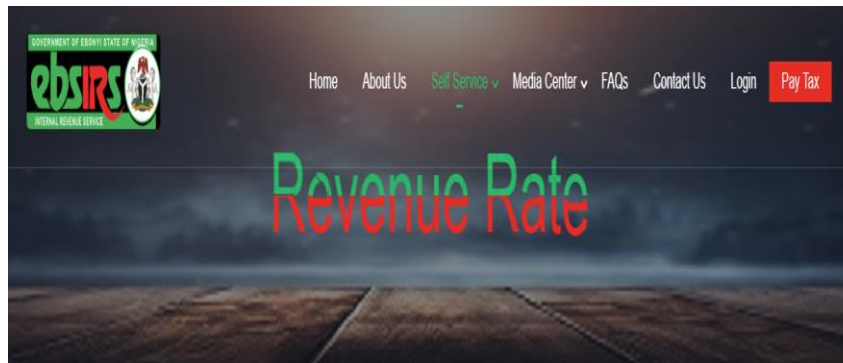

- After submission by the applicant, the Head of Integrated Revenue of EBSIRS approves the submission from the backend **within 24hours** and provide the amount to be paid by the Applicant according to the revenue rate as gazette in Ebonyi State Revenue Law of 2020.

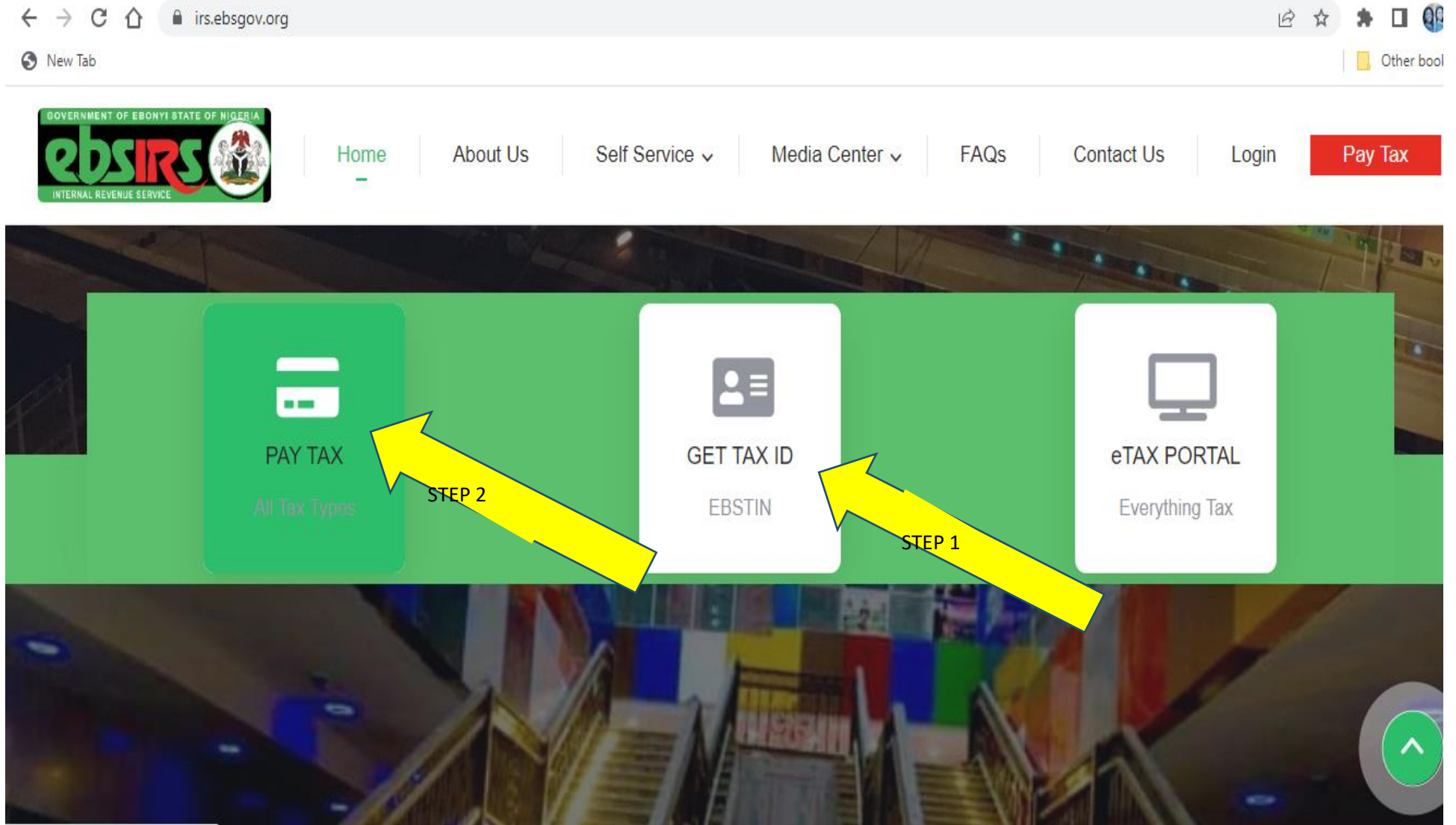

6. The Applicant for the Fire Service Certificate makes an online payment after verification by the HOD Integrated revenue (<https://www.irs.ebsgov.org/pay-tax>)



7. The Applicant gets an automated receipt that serves as annual certificate of registration of the Fire Service Certificate.

NB: The demand notice is for integrated revenue wherein citizens pay for fire services, Business Premises, Waste management, Water Bill, tourism (for hospitality industries), and others.

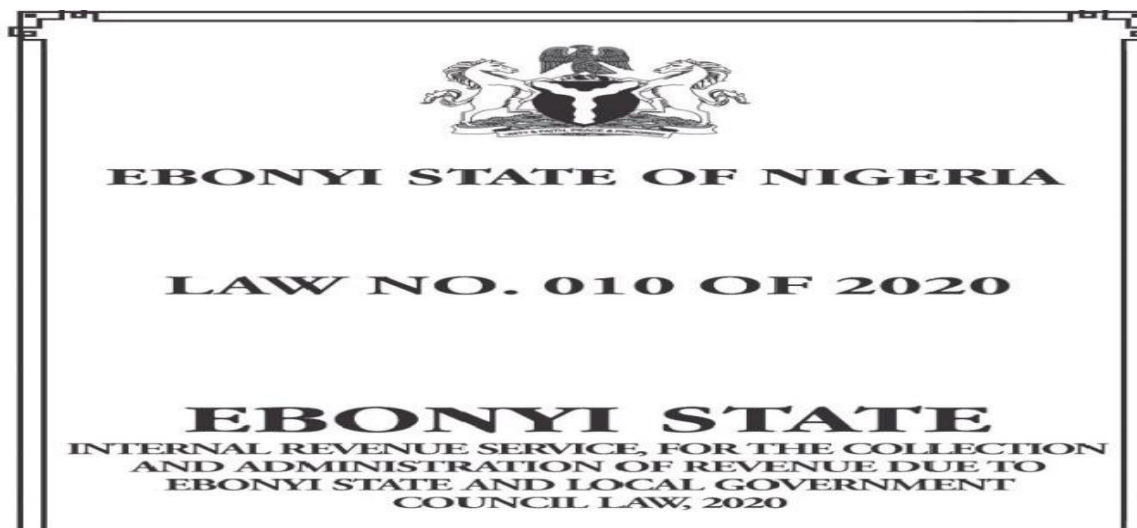

## **CERTIFICATE RENEWAL PROCESS**

Recall that integrated revenue is an annual payment. Same process as above is to be performed annually for the renewal process of the certificate. The receipt that is generated upon payment by the applicant represents the annual certificate given to the applicant in Ebonyi State.
