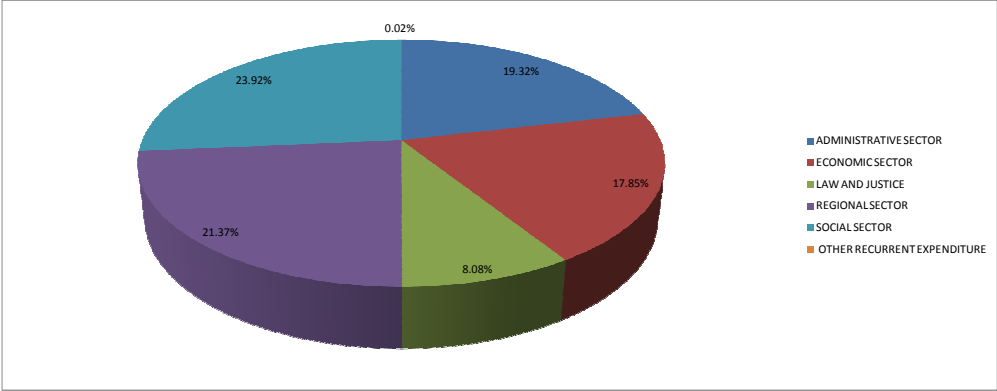

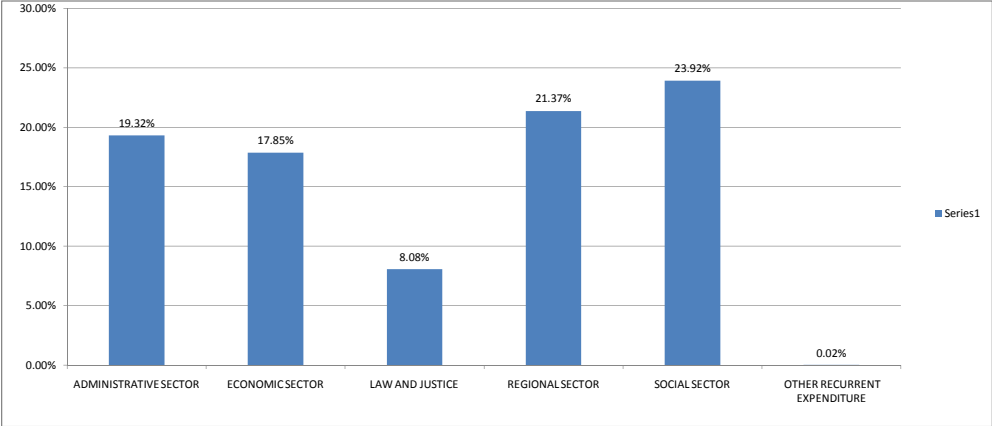

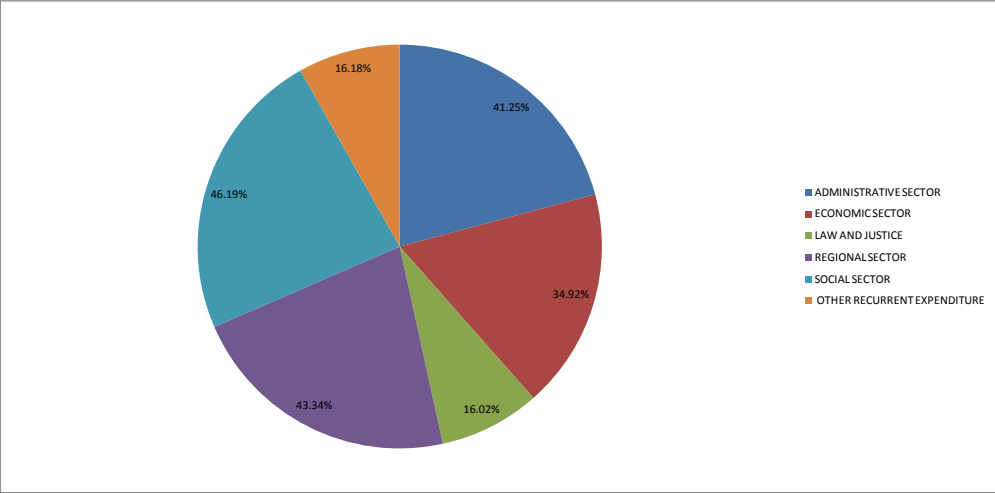
Pie Chart representation of 2nd Qtr personnel cost



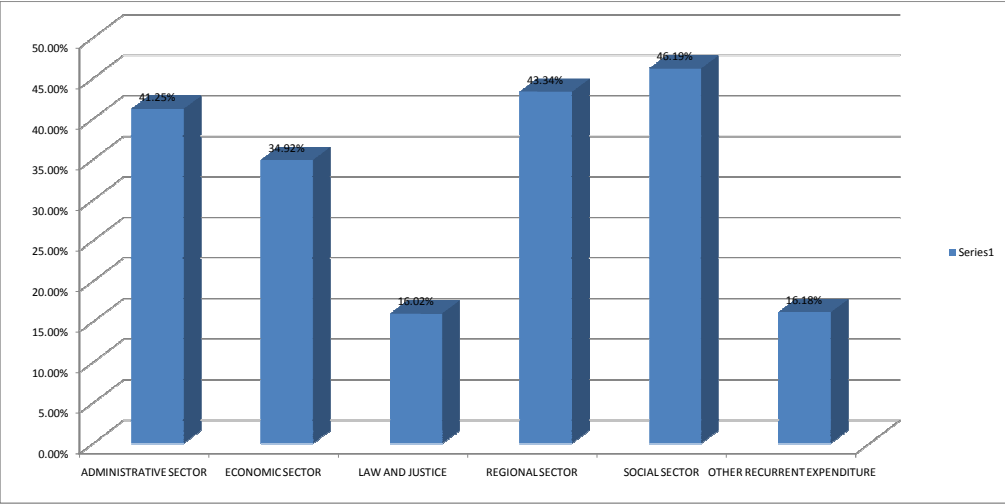
Bar Chart representation of 2nd Qtr personnel cost

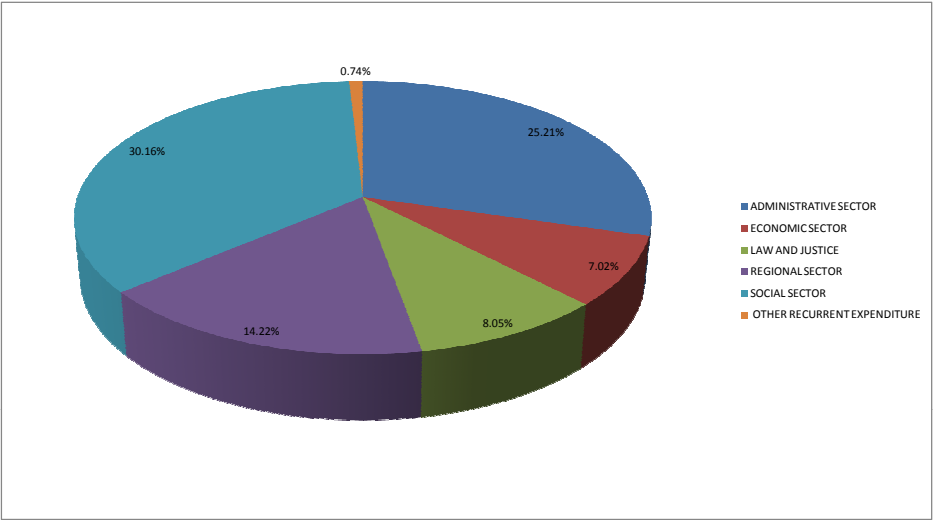

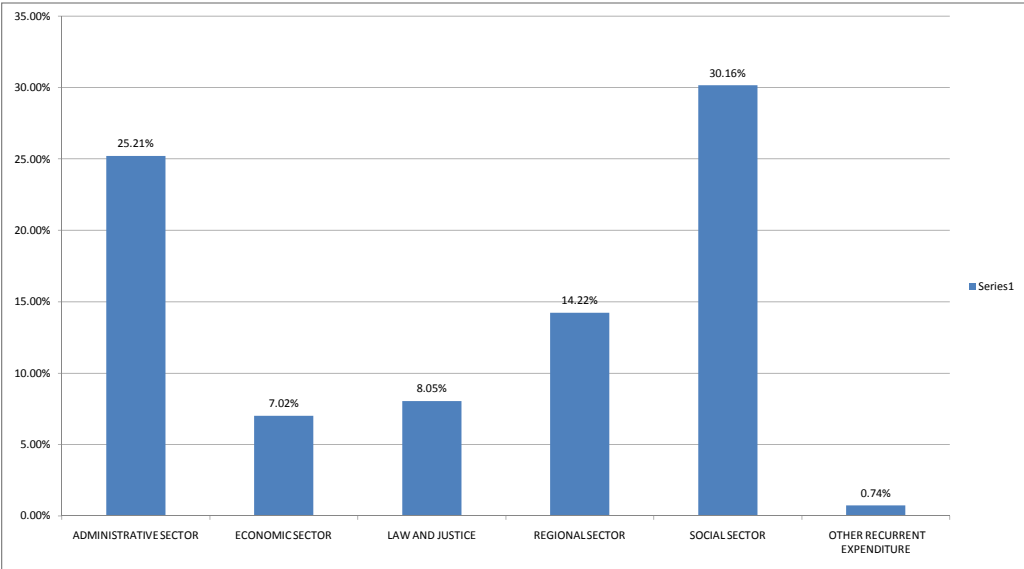

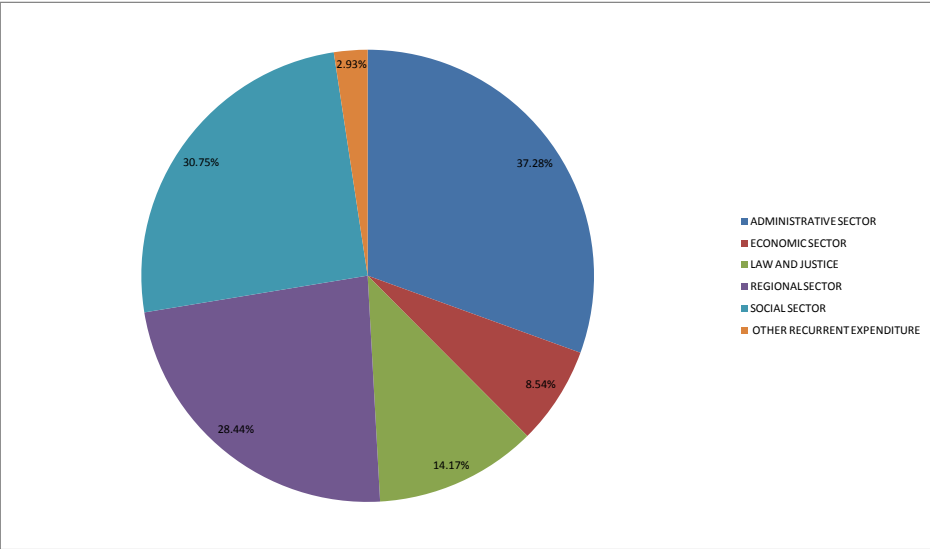
Pie Chart representation of 2nd Qtr Overhead cost/ Special Release



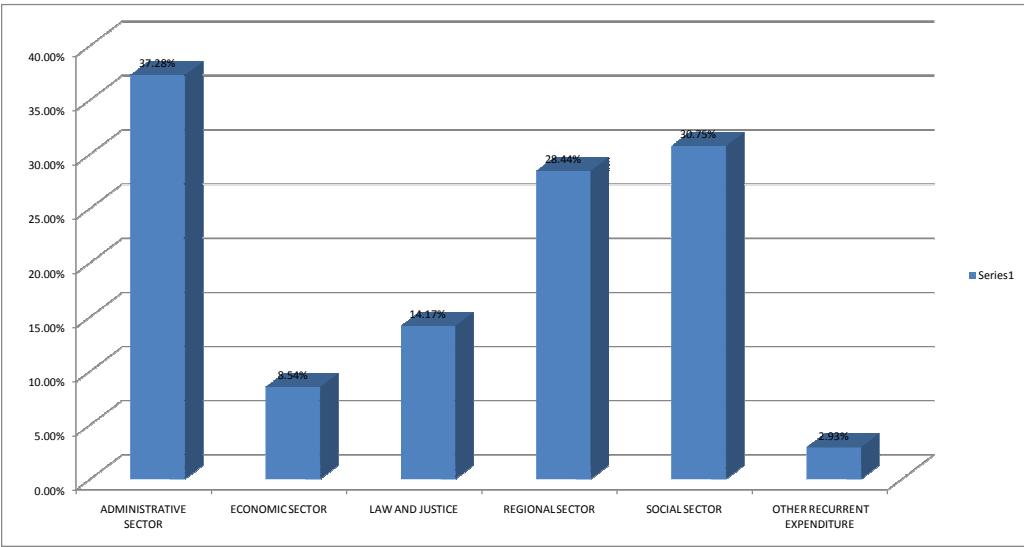
Bar Chart representation of 2nd Qtr Overhead cost/ Special Release

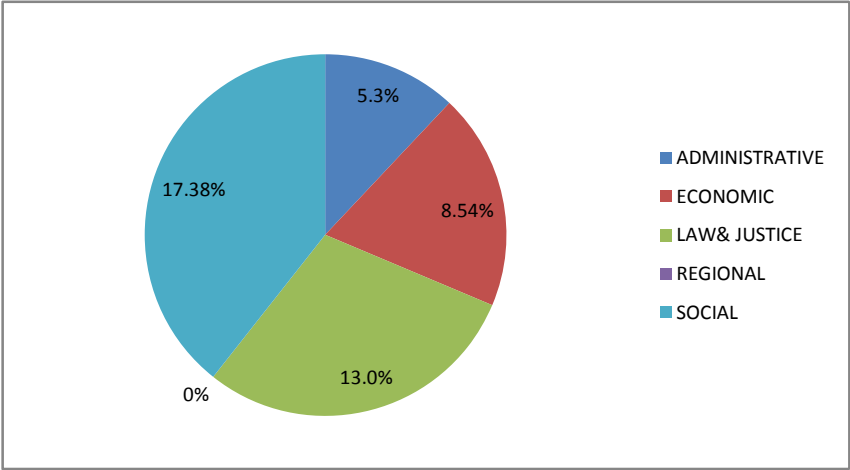

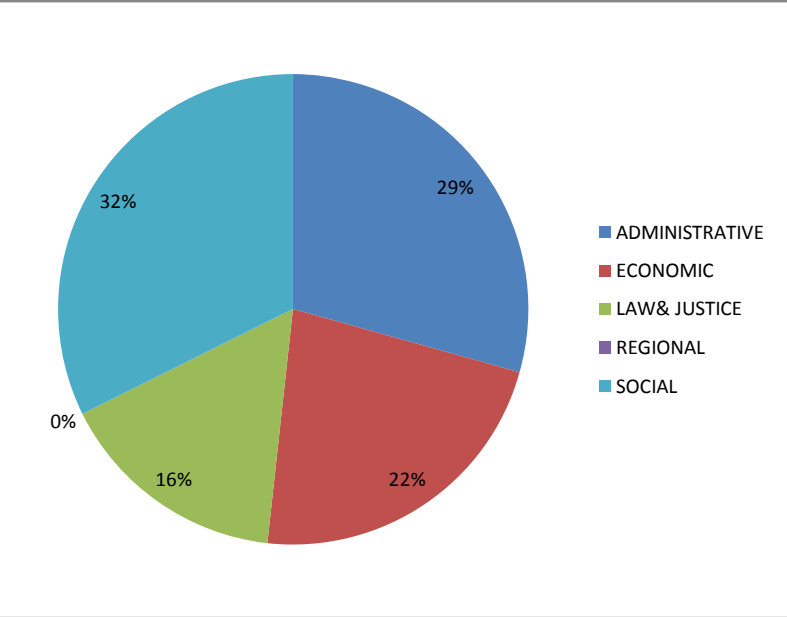
