Consequently, all revenues accruing to Ebonyi State shall henceforth be paid with Tax Identification Number (TIN) into UBA revenue account with a generated invoice from the platform.

You are also notified that his Excellency, the Executive Governor of Ebonyi State, has graciously waived payment of interest and penalties for late filing of tax returns till 30° of September, 2020 to cushion the effect of COVID 19 Pandemic.
