**Commencement**

This Law shall be deemed to have come into effect on Thursday the 11th day of November 2021

**ENACTMENT**

Ebonyi State House of Assembly enacts as follows:

1. The Ebonyi State Audit Law (hereinafter called the Principal Law) is hereby amended as set out as follows:
  2. Amendment of Section 9(3)

Section 9(3) of the Principal Law shall now read *“Persons to be appointed Auditors-General shall not be more than 56 years old at the time of appointment to the office and shall retire on attaining the age of 60”*.
  3. Amendment of Section 9(4)

Section 9(4) of the Principal Law shall now read *“The Auditors-General shall, upon reaching the age of retirement as in section 9(3), be entitled to pension for life at a rate equivalent to the annual salary inclusive of all allowances of the incumbent Auditors-General.”*
  4. Amendment of Section 35  
The marginal note of Section 35 of the Principal Law shall now read ***“Dissolution of the Commission”***
5. Short Title: The Law shall be cited as Ebonyi State Public Sector Audit Law (Amendment), 2021.
