PURSUANT to the powers conferred by Section 8 of the Abakaliki Capital Territory Development Board Law No. 5 of 2007 and all other powers enable it in that behalf, the Board hereby makes the following:-

REGULATIONS

SECTION I:

CITATION AND COMMENCEMNET

INTERPRETATION

This Regulation may be cited as the Abakaliki Capital Territory (Outdoor Advertisement Regulation), 2008.

SECTION 2: In this Regulation, unless the context otherwise requires:

"Advertisement" means any word, letter model, sign, placard, hand an elational illuminated or not
